



**Ale-8-One Basketball Giveaway**  
NO PURCHASE NECESSARY TO ENTER OR WIN.

1. **CONTEST PERIOD:** The Ale-8-One Basketball Giveaway begins at 9:00:00 AM Eastern Time (“EDT”) on February 18, 2019 and ends at 12:00 PM EDT on March 28, 2019 (“Contest Period”).

2. **ELIGIBILITY:** The contest is open only to legal residents of the United States who are eighteen (18) years of age or older as of the date of entry. Void where prohibited or restricted by law, regulation, rule, or otherwise. Employees of Ale-8-One (“Sponsor”), its parents, affiliates, subsidiaries, and advertising and promotion agencies (aforementioned individuals and organizations collectively, “Contest Entities”), retailers, and the immediate family members (spouses and siblings, children and parents and their spouses, regardless of where they live) or members of the same households (whether related or not) of such individuals are not eligible. 5. WINNER NOTIFICATION/VERIFICATION/ADDITIONAL PRIZE RESTRICTIONS: The winners from the ale8giveaway.com submissions will be notified via email. Winners from the Instagram or Twitter drawing, will be contacted on the social media outlet, depending on where they entered, to obtain his/her complete contact information, and to verify his/her eligibility and ability to accept the prize. Any such message will instruct the potential winner to reply as instructed within three (3) full business days (measured in the local time zone) after the time that the notification message was left. Potential winner must reply as instructed within such three (3) full business day period, or he/she will be disqualified.
