



Ale-8-One Float Your Recipe Our Way Contest

1. **CONTEST PERIOD:** The Ale-8-One Float Your Recipe Our Way contest begins at 9:00:00 AM Eastern Time ("EDT") on Monday, August 2, 2021 and ends at 12:00 PM EDT on Wednesday, August 11, 2021 ("Contest Period").

2. **ELIGIBILITY:** The contest is open only to legal residents of the United States who are eighteen (18) years of age or older as of the date of entry. Void where prohibited or restricted by law, regulation, rule, or otherwise. Employees of Ale-8-One Bottling Company ("Sponsors"), its parents, affiliates, subsidiaries, and advertising and promotion agencies (aforementioned individuals and organizations collectively, "Contest Entities"), retailers, and the immediate family members (spouses and siblings, children and parents and their spouses, regardless of where they live) or members of the same households (whether related or not) of such individuals are not eligible. Any such message will instruct the potential winner to reply as instructed within three (3) full business days (measured in the local time zone) after the time that the notification message was left. Potential winners must reply as instructed within such three (3) full business day period, or he/she will be disqualified. In Sponsors' sole discretion, such potential winners may only be notified one time as set forth above for attempted prize notification.
